6 Development at Meadowview

Given the interest in the village the chair asked if there was any objections to the item being brought forward on the agenda
None being made The Chair outlined the concerns being raised in the Village over the above development.

The chair had spoken to the owner of the Land, Mr Eaton, who had confirmed that he intended to open a wholesale nursery from the site.

However as the development itself was of an agricultural nature then no planning permissions were required.

The Planning Enforcement Office (Bryn Mawr) for Derbyshire Dales had inspected the site and had placed a stop on works there given that a road in the site was being constructed with other works that he felt would need planning permission.

With regard to the Goods Vehicle Operators licence the chair stated that the Parish Council had no jurisdiction over the application.

However he stated that Derbyshire Dales Planning Dept would be taking any issues raised by the Parish Council forward on its behalf.

The Chair recommended that any householders affected by the application write to the licencing authority raising their objections.

Villagers asked if their concerns could be documented (see attached) and passed to Mr Eaton for comment

The Chair undertook to do this.
