Planning Applications 18/00750/FUL and 18/00749/FUL

High Grounds Farm Audishaw Lane Boylestone Derbyshire DE6 5AE Proposal Siting of 2 mobile poultry units

The Chair invited Members of the Public to give their views on the above proposals

Comments were taken from the public about application 18/00749/FUL reiterating the issues raised previously.

Mr Oborne and Mr Watson who sent his comments in a letter received by the Clerk were concerned about the lack of consultation offered to neighbours.

The consultation letter apparently sent to the nearest neighbours (Mr and Mrs Pelly) had not been received by them

Clr Morley outlined the Planning Process used within Derbyshire Dales in that Planning was generally approved under delegated authorities by planners unless the application was called in by Councillors for discussion by the Planning Committee for a decision.

This had not been done. However he undertook to call in the application the following day.

Following discussion the Clerk was asked to draft a letter to the Chair of Derbyshire Dales and the Head of Planning expressing reservations about the way the application had been dealt with given the objections by the Parish Council and residents and what recourse residents now had.
