Outstanding Works on Roads etc

Clr Bull reported that Derbyshire County Council had agreed to starting the remedial works on Audishaw Lane and Brook Farm within 3 months

With regard to the other issues on New Road Councillors agreed

To obtain quotes/estimates for (All works to start from Eastern most point at the Junction with the Brook working back up the Hill)

1) To clear out Drainage ditch from junction with Brook on Northern side of New Road and assess drainage culverts under field access is clear as is culvert coming across Road from Southern side

2) To clear drainage ditch on Northern side of Road from Field access to its westernmost termination towards the Rose and Crown

3) to clear out the Drainage ditch on the Southern side of the road towards the telephone box including the ditch behind the hedge in the sports field

- 4) to assess if all the culverts are functioning
- 5) To reinstate the drainage behind the pull in on the Southern side either with a ditch or Culvert
- 6) To ensure that the appropriate permissions are obtained from DCC where appropriate
- 7) to endeavour to obtain a contribution from DCC to the works particularly as the last time the drainage ditch cleaning was carried out was at least 10 years ago
- 8) If possible to investigate and clean the drainage gullies from Chapel lane to the Eastern side of the Rose and Crown as to their functionality
- 9) Clerk and Councillor Watson to put together Letter to DCC outlining issues and asking for contribution or a timescale as to when they would propose to carryin the works should DCC decide to do them
